Qualifications

- Attend conference and Annual Meeting
- Volunteer at events, as required
- Engage in critical thought and be committed to a vibrant future for the organization
- Prepare well for meetings, reviewing and commenting on minutes and reports
- Actively participate, listen well and be thoughtful in considering issues
- Get to know other directors and build a collegial working relationship that contributes to consensus
- Actively participate in the board's annual evaluation and planning efforts
- Understand the fiscal implications of decisions

Responsibilities

- Provide strategic leadership
- Be knowledgeable about the organization's values, mission, programs and performance
- Be an ambassador for the organization and promote its work in the community
- Ensure the organization's financial viability and sustainability
- Develop policy frameworks
- Participate in fundraising efforts

^{*} All Board of Directors shall be at least 18 years of age and a legal resident of the United States. If a Board of Director is not a resident of the Commonwealth of Virginia, he/she must perform work for an employer that conducts business in the Commonwealth.

To carry out these responsibilities, the Board meets monthly throughout the year. In addition to attendance at Board meetings, you will be required to participate on committees.

The Board is comprised of up to 12 members elected at the Annual Conference, typically held in late April to early May. Once elected, a Director shall hold office for a 3-year term and until a successor has been elected and qualified for office. Members may serve a maximum of two consecutive 3-year terms.
